Subject: Governing Board Discussion on Intellectual Property Policy

## **Executive Summary:**

During the October meeting, Board members requested further Board discussion on NORCOM's policy related to intellectual property. Topics for discussion include application to member agency staff, identifying and determining when NORCOM should seek to preserve intellectual property rights, and the process for the inventor reward program.

# Background:

NORCOM has had an intellectual property policy in place since 2013 and has also requested and received NORCOM employee assignments of intellectual property developed by them while NORCOM employees. NORCOM's attorneys have provided an updated policy that reflects current practice.

NORCOM policy of this nature is normally within the authority of the Executive Director. Several unique aspects related to Board policy led NORCOM's attorneys to recommend that the Executive Director brief the Board on changes to the policy and seek Board concurrence.

Subject: Initial Briefing and Study Session on ZEN Task Force Work

## **Executive Summary:**

In April-May 2019, Renton Regional Fire Authority and Puget Sound Regional Fire Authority requested quotes from NORCOM for emergency communications service. Following an initial briefing on the request to the NORCOM Governing Board, NORCOM staff established a task force to obtain information and conduct analysis necessary to determine feasibility, impact, and cost. The Task Force is known as the ZEN Task Force. The Zen Task Force has worked diligently to analyze NORCOM internal data as well as data from the two fire authorities. The analysis is largely complete and ready for further discussion at the Board level. The task force will update the Board on its research, methodology, and preliminary conclusions. The Task Force seeks Board feedback and further direction on all aspects of its work.

#### Background:

Valley Communications currently provides emergency communications services to the Puget Sound Regional Fire Authority and Renton Regional Fire Authority. Both agencies have expressed interest in NORCOM providing those services.

#### Past Board or Other Related Actions:

The Board approved NORCOM staff to analyze and report back on feasibility.

#### Policy and Strategic Implications:

NORCOM faces declining outside revenue. The addition of new agencies would lower current agency costs, improve public safety service across a wider region, and mitigate future outside revenue reductions. Adding additional agencies could negatively impact performance. NORCOM's ZEN task force has worked to analyze both positive and negative policy and strategic implications.

NORCOM staff believes it is important to brief the Board on the results of it analysis and seek further direction.

Subject: Washington State 911 Efficiency Study

#### **Executive Summary:**

The Washington State legislature mandated a 911 Efficiency Study in the 2019 state budget. The State 911 Office (SECO) has completed the organizational work to carry out a 911 efficiency study. This group represents a cross-section of 911 stakeholders from across the state. NORCOM has requested information on the stakeholders and organizational framework. The group is now scheduling meetings that will culminate in a final report that is required to be complete by October 20.

# Background:

ESHB 1109 – House of Representatives budget allocated \$100,000 of the E911 account for a collaborative group with representatives from counties, PSAPs and first responder organizations to submit a report on the 911 system by 10/1/2020. The report must include:

- Actual cost per fiscal year to operate and maintain the 911 system including, but not limited to, the ESInet, call handling equipment, personnel costs, facility costs, contractual costs, administrative costs, legal fees.
- The difference between the actual state and local costs and current state and local 911 funding
- Potential cost-savings and efficiencies through the consolidation of equipment, regionalization
  of services or merging of facilities, positive and negative impacts on the public, legal or
  contractual restrictions, and appropriate actions to alleviate these constraints.

#### **Past Board or Other Related Actions:**

None

#### Policy and Strategic Implications:

Ten states have adopted, considered, or have pending PSAP consolidation legislation. The 911 Efficiency Study seems to track with the Missouri model which began with a 911 Efficiency Study followed by legislation mandating consolidation of PSAPs. A summary of related PSAP consolidation legislation from other states is attached. PSAP consolidation legislation typically reduces or limits eligibility for 911 surcharge tax revenues unless PSAPs are consolidated or sharing resources. Some states such as Illinois have restricted the number of PSAPs allowed for each county. PSAP consolidation legislation in Washington State could impact NORCOM's outside revenues. Currently, 911 surcharge taxes represent about 13% of NORCOM's total budget.

#### **NORCOM Staff Recommendation:**

NORCOM staff recommends active engagement by NORCOM and its owner agencies as the study progresses.

NORCOM staff continues to engage with the State 911 Office and other 911 stakeholders on this important study.
